**WITH THE JUNE 30, 2022 PUBLICATION OF THE FINALIZED 2025/2030 CECP REPORT (CLEAN ENERGY & CLIMATE PLAN) THE COMMONWEALTH WITHDREW ITS PREVIOUS RECOMMENDATION THAT 60,000 ACRES BE EMPLOYED FOR SOLAR.**

**THE 2025/2030 CECP FINAL REPORT FOR THE FIRST TIME PROVIDES AN ANALYSIS OF THE EMISSIONS FROM, AND THE CARBON SEQUESTRATION BY, MASSACHUSETTS' NWL." (NATURAL & WORKING LAND)**

**TO PROTECT THE COMMONWEALTH'S NATURAL RESOURCES FOR CARBON SEQUESTRATION AND OTHER BENEFITS, MASSACHUSETTS WILL INCREASE THE STATE'S EFFORTS TO PERMANENTLY CONSERVE AT LEAST 28% AND 30% OF UNDEVELOPED LAND AND WATER BY 2025 AND 2030, RESPECTIVELY.** P.XV/2025/30 CECP FINAL REPORT

# WHERE SHOULD SOLAR BE SITED

**ECAC (AMHERST'S ENERGY & CLIMATE ACTION COMMITTEE), RELYING ON THE INTERIM DRAFT OF THE 2025/30 CECP REPORT (DEC 2020) AND THE 2050 ROADMAP (DEC 2020), HAS URGED AMHERST TO USE "HUNDREDS OF ACRES" (335) FOR LARGE SOLAR INSTALLATIONS, CHARACTERIZING THIS AS THE TOWN'S "FAIR SHARE."**

# **SOLAR ON “BUILT” LANDSCAPES**

**THE STATE RECOGNIZES THE CHALLENGE OF IDENTIFYING SUITABLE SOLAR SITING OPTIONS, AND REPORTS THAT DOER (DEPT. OF ENERGY RESOURCES) INITIATED “A TECHNICAL POTENTIAL OF SOLAR STUDY” IN 2022 THAT WILL CREATE A RANKING OF PREFERRED AND LEAST PREFERRED LOCATIONS FOR SOLAR IN MASSACHUSETTS, CONSIDERING ENVIRONMENTAL, LAND USE, AND ECONOMIC FACTORS. **DOER WILL CONTINUE TO ENCOURAGE SOLAR AND STORAGE PROJECTS ON “BUILT” LANDSCAPES. “THE TECHNICAL STUDY” WILL HELP INDICATE HOW MUCH SOLAR WOULD BE SITED IN THE COMMONWEALTH CONSISTENT WITH THE PROTECTION OF CRITICAL LANDS AND HABITAT.**
